TERMS & CONDITIONS

RESERVATIONS

Travelers must complete and submit a registration form along with a **deposit of \$500** per person by **January 4, 2021**. Fee **balance due** by **February 5, 2021**. A processing fee of **3.5%** will be applied to all **credit card charges**.

CANCELLATION POLICY

All cancellations must be submitted to the tour operator in writing. Cancellations made 91 days or more prior to departure will be charged an administrative fee of \$200; 90-60 days prior to departure will be charged \$450; 59-46 days prior to departure will be charged \$650; 45-31 days prior to departure will be charged 50% of tour fee; 30-0 days prior to departure will be charged 100% of tour cost.

DOCUMENTS

All participants must have a U.S. Passport that is valid for 6 months beyond tour return date.

TOUR MEMBERSHIP AND MOBILITY

Tour membership is available to all travelers and will not be withheld if the tour operator can furnish the requirements that an individual may need. Most of our sightseeing schedule requires participants to walk 1-2 miles daily using a moderate pace. We cannot accept persons who are not able to navigate uneven terrain or need assistance. Should meeting these requirements materially add to the tour operator's cost, the participant will be expected to pay these additional costs. The tour operator retains the right to require non-mobile persons to stay behind when deemed necessary, and also terminate the membership of any member displaying disruptive behavior, delaying or endangering fellow members and/or interfering with the operations of the tour.

RESPONSIBILITY

HeartLink Network and their agents act only in the capacity of agents for the passengers in all matters pertaining to hotel accommodations, sightseeing, tours and transportation, whether by air, railroad, motor coach, water craft or other means, as such, hold themselves free of responsibility for any damage(s) from any cause(s) whatsoever. The tour operator will not be responsible for any damage, expense or inconvenience caused by late air, ground, rail or boat arrivals or departures or by any change of schedules or other conditions; nor will they be responsible for the loss of, or damage to baggage or any article belonging to the passenger. The right is also reserved to decline or accept or retain any person traveling under our auspices. The carriers concerned are not to be held responsible for any act, omission or event during the time passengers are not on board their plane or conveyance.
